# Anima Alternative Sgr completes first closing of 'Anima Alternative Growth' fund with commitments of €100 million

Milan, June 16<sup>th</sup>, 2025 - Anima Alternative Sgr announces the first closing of "Anima Alternative Growth" alternative fund (AIF) with commitments of  $\in$ 100 million from institutional investors, pension funds, banks and insurance companies.

Anima Alternative Growth will invest in **hybrid capital instruments** such as mezzanine debt, PIYC (Pay if you can) financing, minority preferred and ordinary equity, which are particularly suitable for building tailor-made patient capital solutions. The fund aims to offer **flexible solutions that fit the needs of Italian SMEs** and - to a lesser extent - of the Eurozone, traditionally less supported by these financial instruments than large companies.

Anima Alternative Growth, the third AIF launched by Anima Alternative Sgr in just four years, set its fundraising target between  $\leq 150$  and  $\leq 200$  million, which will take Anima Alternative's total commitment over the threshold of  $\leq 500$  million, thus confirming it as one of the leading players on the private capital industry in Italy. The fund is also classified under Article 8 of the SFDR regulation and, as such, is committed to invest in companies that have a positive approach to ESG issues.

This new instrument will benefit from the positive track-record of the two other AIFs launched by Anima Alternative Sgr, proving the effectiveness of its investment approach. Anima Alternative 1, launched at the beginning of 2021, has been fully invested in 13 companies and has already completed five divestment (exit) transactions, with a realised IRR (internal rate of return) of over 11%. Part of the proceeds will be distributed to investors, contributing to bring the fund's DPI to over 0.5x.

Anima Alternative 2, with its focus on senior debt strategies, successfully closed its fundraising with a total of  $\in$ 196 million. The fund has already made 19 investments. Two years after its launch, it has invested 64% of its committed capital, in line with its targets, and has already completed three exits, with a realised IRR of 10%.

"Anima Alternativestands as one of the key players able to offer hybrid solutions to support SMEs, which have always represented the heart of the Italian entrepreneurial environment", commented **Philippe Minard**, **Investment Director of Anima Alternative Sgr**. "This innovative approach addresses the growing demand for flexible financing instruments, which are still not widespread in Italy compared to other European countries, where the private capital market is more developed. We see a wide room for growth in the market for this type of fund, and we are ready to seize the opportunities that will arise".

It also owns 80% capital of Castello Sgr, a leading company in the promotion and management of alternative investment products primarily in real estate. Since April 2025 Anima is part of the Banco BPM Group.
